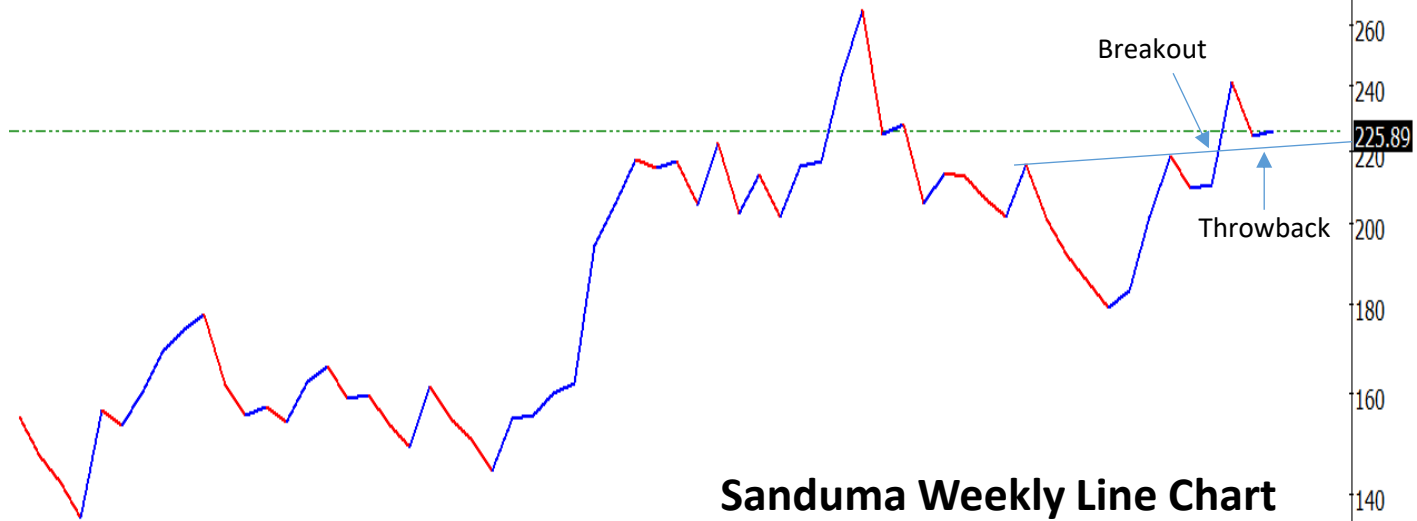

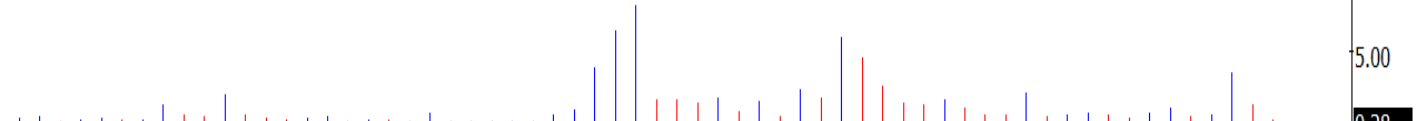


Sanduma Weekly Line Chart

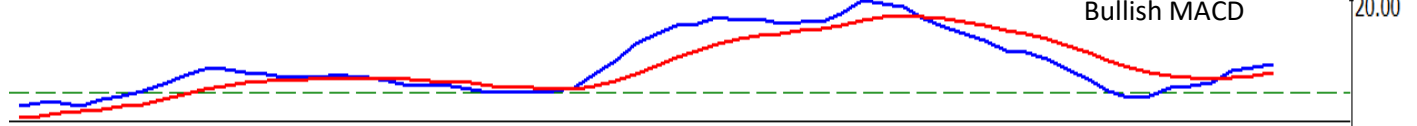

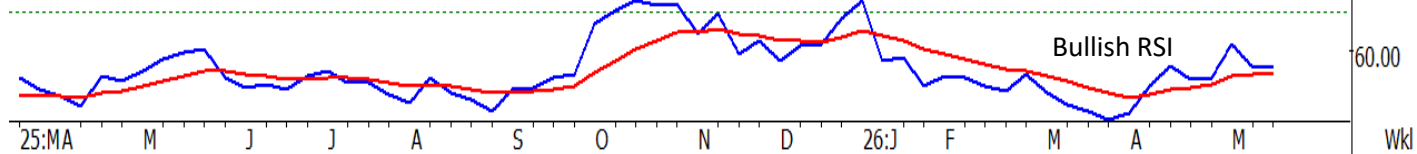
